

Oklacon 2010 Guardian Permission Form

General Information

Oklacon is a three day event hosted at Roman Nose State Park in Watonga, Oklahoma each year in October to raise money for Safari's Interactive Animal Sanctuary. This form must be completed, signed, and notarized for each individual between the ages of 16 and 18 who wish to attend the convention. Individuals under the age of 16 at midnight of October 28, 2010 must be accompanied by a legal guardian. This convention provides a number of outdoor activities, including hiking and volleyball. The cost of registration will include access to most areas of the convention and two meals over the course of the convention, and small snacks will be sold at a concession stand throughout the event. It is the responsibility of the legal guardian to provide or secure appropriate transportation for the minor, not arriving before 9 AM on October 22, and not departing later than 6 PM on October 25. It is also the responsibility of the legal guardian to ensure any minor that attends has appropriate food or funds to purchase their own food. Because of our scenic location, cell phones usually do not have enough reception to make or receive calls. In the event of an emergency, you may contact the main dining hall at our camp site at 580-623-9955 and ask to speak to Andrew Ryerson, Bonnie Koch, or Sean McElroy or another Fuzzy Productions staff member. While Oklacon strives to provide a weekend of family-friendly fun, all minors will receive a special badge indicating they are a minor, and they will not be granted access to some adult areas of the convention, such as the art auction.

Parental Permission
