

Oklacon Dealer's Den Agreement

Policies and Procedures

1. Oklacon will host a Dealer's Den for vendors to sell works of art. Though Dealer's Den shares some common areas with Artists Alley, only in Dealer's Den may registered attendees act as third party agents to sell the work of others.
2. The Dealer's Den is a general audience area. All works on display must be appropriate for an audience of all ages. Mature works must be shielded with opaque materials to hide any mature elements, including female breasts, genitalia, and excessive gore. Alternatively, mature works maybe collected into a separate binder clearly marked as inappropriate for minors, and the vendor may allow others to peruse a mature binder at their table after checking for non-minor badges.
3. Only registered, paid attendees will be granted access to the Dealer's Den at Oklacon. Those without convention badges will not be permitted to purchase a table in the Dealer's Den.
4. Dealer's Den tables are full-tables and cost \$25 for the entire convention. Each pre-registered and prepaid attendee may purchase only one table before October 1 by sending both this signed agreement and either a money order or a check made payable in the correct amount to the "Oklacon Association for Anthropomorphic Arts" and mailed to the address below. Do not mail cash.
5. All entrants, including Oklacon volunteers, must pay to reserve space.
6. Convention attendees are not allowed to sell works of art outside of the Art Show and Auction, Artists Alley, and Dealer's Den.
7. Unclaimed or otherwise available Dealer's Den spaces may be purchased at the door by cash only. The Oklacon Art Director will consider spaces empty at noon on each day unclaimed and forfeited for that day, even if they are paid for in advance. No refunds will be issues for unclaimed spaces that are resold to another vendor. Vendors on the waiting list for space will be given a chance to purchase unclaimed spaces for \$15 for a one-day pass on a first-come, first-serve basis. The Oklacon Art Director shall maintain all waiting lists and be the sole determiner of space availability.
8. Vendors are responsible for watching and securing their own items and materials in the Dealer's Den. Neither Oklacon nor Fuzzy Productions, LLC assumes liability for damaged, lost, or stolen items from the Dealer's Den.
9. Items left after the close of the convention shall become the property of Fuzzy Productions, LLC. Items shall be returned to the original vendor within 90 days of the convention at the vendor's shipping and insurance expense. Abandoned items shall be auctioned off by Fuzzy Productions, LLC in the next year's Oklacon Charity Auction.

Content

1. Oklacon reserves the right to refuse service or display privileges to anyone. The Oklacon Art Director has final say in all matters concerning what items are allowed in the Dealer's Den and how items are allowed to be displayed.
2. Oklacon is a themed convention, and the Oklacon Dealer's Den is a themed event. The majority of items created or displayed should be substantially depicting anthropomorphic an "anthropomorphic" (animals with human characteristics), "theriomorphic" (humans with animal characteristics), wildlife, or science fiction/fantasy creature nature.
3. Characters which are trademarked, subject to copyright, or which are the well-known property of a person other than the vendor may be sold and displayed without express permission of the holder of the trademark/owner of the copyright/creator of the character. Written proof of permission from the trademark/copyright/character owner must be provided for all reproductions and prints of any original works not belonging to the vendor.
4. Weapons, no matter how artistic, may not be displayed.
